- 3. Complete a separate Transmittal Form and Check Listing for each currency J.P. Morgan will assign a reference number to each Check Listing and, therefore, each currency. If you need a reference number for each check within a currency batch, please complete a separate Form for each check.
- 4. The bank of first deposit should stamp the back of the check with a Prior Endorsement Guarantee stamp.
- 5. Please complete a separate Check List for any check greater than \$40,000 USD Equivalent.
- 6. Keep front and back copies of each check and this Form.
- 7. Courier the check(s) and the Form(s) to the address printed below. We suggest you use a form of delivery that provides a receipt and tracking capability.
